### No. 3 REVISION OF ARTICLE VIII LOCAL GOVERNMENT

#### November 5, 1968

FOR: 9,552 (53.67%)

AGAINST: 8,247 (46.33%) Proposing a Revision of Article VIII of the Constitution of the State of Florida relating to counties and municipalities, providing for creation of counties by law, requires matters relating to county funds to be prescribed by general law, allows method of election of certain elected officials to be changed or office abolished when prescribed in the county charter or by special law approved by voters, gives municipalities residual powers except as provided by law, provides for consolidation of county and municipal government, subject to approval of electors, et. cetera.
